

## General Terms for Registration

1. A **non-refundable trip deposit** (see group organizer, flyer or contact our office for deposit amount) per applicant and a completed signed registration form are required to secure a reservation.
2. The trip deposit is due by the pre-established published deadline (see group organizer, flyer or contact our office). The trip deposit reserves your space and is based on space available at the time of booking and will be applied to your final trip balance due.
3. Final trip balance is due 45 days prior to trip departure date.
4. All trip payments can be made to **Lasting Impression Tours, Inc.**, by check, money order or credit card (Visa, MasterCard, Discover Card)
5. All returned checks will be subject to a \$40 collection fee. Checks will not be resubmitted to a bank. You will be required to pay all future trip payments by money order.
6. **Deposits are non-refundable.** Optional cancellation insurance is available, and recommended.
